Mrs. Whelan shared the district had recently made payments toward their current bonds. She indicated the district was on pace with their expenditures and revenue being approximately ½ through the year.

5.3 Superintendent Report

The board wanted to explore the possibility of addressing some concerns that have been expressed by the elementary staff concerning overcrowding which has resulted in creating a satellite classroom for one section of kindergarten and the ECE program in the Salem Lutheran Church. There has also been concerns expressed about the exterior of the elementary siding. The other issues being explored are the lack of seating capacity and ADA compliance of the high school gym and the needed upgrades of the HS science labs. As part of this exploration the board is looking to determine the bonding capacity of the district and the impact it would have on our taxpayers. The goal is not to see an additional burden on the community in addressing these concerns. Two firms came in to provide possible options to begin discussions with staff. parents, and community; Architechnics, Inc. and Ameresco. Supt. Riddle and the board invited faculty and staff to attend in these initial concepts and planning presentations. Both the superintendent and the Board want to meet with community members to gain their perspective and input into these concerns. The belief is as a collective group we can find solutions which best serve our students and the community.
