5. Administrative and Committee Reports

5.1 Principal Reports

Mr. Dorethy and Mr. Klusmeyer shared the HS had an enrollment of 183 and the MS was at 252 currently. Both reported the start of the school year was going well and praised the new staff and how well they have fit right in. Mr. Ellerman echoed the sentiments about the start of the year and his new staff. Currently the elementary has 201 students and the PReK has 21.

5.2 Business Manager Report (Financial Dashboard)

Mrs. Whelan shared a positive report on a financial snapshot of the district. She also shared the preliminary budget which will be available for public inspection for 30 days.

5.3 Special Education Coordinator

Mrs. Gronewold reported an increase of three (3) additional students with IEPs from last year's numbers. She also indicated the PreK/ECE program was up one (1) student from last year.

5.4 Superintendent Report

Supt. Riddle discussed the opening of school and the first few days and praised the staff on a great beginning of the school year. Based upon the enrollment numbers for the district we saw a decrease of 26 students overall.

We have had some issues in the HS/MS kitchen with the freezer and cooler which have been fixed. Additionally we have had the roof inspected and are waiting on a report to determine possible repair or replacement to combat the continual leakage experienced on this campus.

Supt. Riddle informed the board of the new SRO Deputy Javier Lofton with the Adams County Sheriff's Dept. He has done a nice job of meeting and greeting the staff and students and has made himself very visible.

A Pre-Bid Meeting was held Aug. 20th for the elementary addition project. It was well attended. The architectural team from Klingner's provide a more in-depth description of the project and with Supt. Riddle and Principal Ellerman toured the site with the perspective contractors. Bids are due Tuesday, Sept. 9, 2019 at 3:30 PM at the District Office. Due to the construction, the start date for the 2020-21 school year will be pushed back to August 26 for students. This will provide additional time for completion of the construction project.

Supt. Riddle reminded the board the Meet the Mustangs night is Friday beginning at 5 pm for volleyball and football follows. Also, the Friends of Unit 4 Fall Festival will be Sept. 14.
