Stain would wear in high traffic areas after a while. The Board would like Klinger's to come to the next meeting to discuss this.

Based upon the requests of Mr. Ellerman and Mr. Klusmeyer to add two more teachers for next year the suggestion has been made to delay the transition of the 5th grade to the elementary school until the following year. This has been discussed with the staff and they are amenable to either approach. This would allow the current 4th graders to remain on the HS/MS campus and not have to return to the elementary campus.
