Mrs. Sheffler shared the elementary is busy with field trips, the Spring Book Fair, and many other activities. We will have Kindergarten RoundUp Thursday, May 5 at 12:30-1:30. The 3rd grade will have their Wax Museum Friday, May 6.

Mr. Arnsman let the board know HS Awards Day would be May 11 at 1 pm and graduation would be Friday, May 13 at 6 pm. He also added that 8th Grade Recognition would be May 18 at 1:30 pm. He indicated they had been busy planning for finals and then for summer school.

5.2 Business Manager Report

We are a little over 75% through our fiscal year and doing well. We do have some inflated funds at this point due to some outstanding expenses for projects still in progress which will be costly.

5.3 Special Education Coordinator

Mrs. Stegner stated they had ECE screenings on April 8, 2022. We screened a total of 31 students. It went very well. Mrs. Sheffler and Mrs. Stegner will work on creating class lists for next year. Thank you to Christy Hibbert, Nicole Schaffnit, Tricia Arnsman, Carly Arnsman, Alese Speckhart, Jess Gray and Andrea Schaffnit for making the ECE screenings go so well.! CUSD 4 was selected to participate in the Indicator 14 (Post-Secondary Outcomes) survey this year. We will contact students (with IEPs) that graduated in 2021 and complete a survey about what they have done since exiting high school. The survey window is from May 2, 2022 through August 31, 2022.

5.4 Curriculum, Assessment and Technology Director

Mr. Klusmeyer informed the board that the majority of testing for this year has been completed. This included the IAR for K-8th grades, PSAT and SAT for the freshmen through juniors. This week students are finishing up with their MAP Testing and he predicted the performance level should be improving.

5.5 Superintendent Report

It appears staff and students are on the countdown until the end of the school year. It is in sight and many are ready for summer to begin. Students are done May 20 (extra day due to snow day). Staff will have a Teachers Institute Day May 23.

We have been approved by our insurance company to move forward on the light pole and light repairs. We are waiting on materials to arrive and it will be completed. The boiler situation has been working well. We are waiting on a stretch of dry weather where they can be permanently placed in the tower. We are still waiting on replacement HVAC units for two of our classrooms. We have met as an administrative team to discuss summer programming. We are having difficulty finding staff that are willing to teach summer school. We do have some staff that are interested in working over the summer with the maintenance and custodial crew for the annual cleaning, moving furniture, etc.

Supt. Riddle shared he has been working with Mr. Blunier on a couple of other grants for the shop. We have secured one with ADM for approximately \$15,000. We also have one with the Tracy Family Foundation. They are going to be making a sight visit to further review the request. A date has not yet been set for the visit.

Supt. Riddle informed the board he had secured funds through our ESSER III grant which have been earmarked for the elementary playground. Mrs. Sheffler is working with her students and staff on developing what they would like so we may begin that project.

Supt. Riddle let the board know that he had attended this month's ISBE Board meeting with the Make It Local superintendents group to express the concern many districts felt ISBE was working against them and not for them. The group spoke asking for ISBE to be more transparent in their support/opposition to bills affecting K-12 public schools. We also reiterated that we have communities that do not support CRT and the Sex Ed curriculums as well as the requirements for asking minors questions about their sexual orientation and sexual preferences. We asked that ISBE work with us and we would work with them given the opportunity.
