5. Administrative and Committee Reports

5.1 Principal Reports

Mr. Arnsman shared the MS/HS has been doing well. The "Battle of the Rtls" has been very successful. We are seeing great participation from

all students...even some who normally do not join in. Another positive note we have seen a marked decrease in the number of failing students with the onset of sports again. The recent Parent-Teacher Conferences were not as well attended as we would have hoped but those who did meet were very productive.

Mr. Ellerman commented on the elementary also doing well. Staff was able to meet virtually with parents for their Parent-Teacher Conferences.

- 5.2 Business Manager Report (Financial Dashboard)
 - Mrs. Whelan shared the year if 58% through and financially we have been able to control costs well. We have seen some reductions in expenditures due to the decrease in activities but there has also been an increase in covid costs which has equaled the decrease we have seen. The projected reduction in revenue of approximately 15% is holding true.
- 5.3 Curriculum, Assessment, and Technology Director

 Mr. Klusmeyer provided a review of the district MAP testing done on the K-8 students this fall and winter. We have seen an impact across the board from the forced remote learning last spring and the intermittent in-person learning this year due to quarantining with students underperforming. Of particular concern are the Kindergarten and 1st grades loss of reading instruction last year typically done during the spring. The staff has provided more small group instruction as well as individual work to help improve student growth. Unfortunately this will be a long term effect which will require continued strategies to recover the loss of instruction during the pandemic time.
- 5.4 Superintendent Report

Supt. Riddle began his report with the governor's budget address earlier today. Gov. Pritzker has proposed a spending plan that does not include any additional state dollars into the Evidence-Based Funding (EBF) Formula. We know not investing in the EBF will push districts further away from their adequacy targets and make it harder for schools to provide additional academic and social-emotional support for students. Gov. Pritzker is holding out hope for more federal aid from Washington now that President Joe Biden is in the White House and Democrats control both houses of Congress. His hope is the federal dollars can be used to offset the money needed for education. However, the reality is much more complicated. In addition to a possible \$3 billion deficit, the state still faces a nearly \$4.9 billion backlog of unpaid bills and \$2.8 billion still outstanding from the \$3.2 billion Illinois borrowed from a special Federal Reserve program to help shore up its past two budgets during the pandemic, money that must be paid back within three years. This again puts school districts left guessing at the level of funding they will see.

Supt. Riddle shared the average enrollment has held steady this school year at approximately 660 students K-12. We will soon be making plans and scheduling for next school year and we anticipate numbers to be consistent with past years. At this point we have not seen numbers changing much due to covid or families relocating for work. The start up of some of our school sponsored sporting events has been time-consuming working through the changing guidelines trying to maximize the number of parents attending contests. Mr. Cash has been working at putting the guidelines in place for our home athletic contests. Supt. Riddle informed the board he is working with Klingners and Maas Construction to complete the punch list items which are still

outstanding. There have been some issues which have not been resolved. He also updated them on the HVAC system and the continued problems we have been having on the MS/HS campus. There have been costly needed repairs and replacement of classroom units. This system has been problematic since it was first installed. He also spoke concerning the science lab design progress. We are still waiting on plans and projected costs from Klingner.

Finally the recent extreme temperatures have created a dramatic spike in usage and cost for electricity and natural gas. Ameren as well as our own energy supplier have requested we limit usage as much as possible. The request was to set thermostats at 68 degrees which we have. We asked all students and staff to dress warmly if they feel the need. We have had some wearing jackets but we also have some students wearing shorts. Hopefully this will be short-term.
