Both principals reported they are busy with summer work getting prepared for the school year. They have been busy hiring personnel, working on the handbook and completing scheduling.

  - The end of the fiscal year and the district is doing well. The auditors will be in at the beginning of August.

We are working on finishing out grants and state reports prior to July 31. We have been able to utilize many grants to help us offset many costs normally incurred by our district. We are working to continue this going into next year. The high impact tutoring and the ARP ESSER

III have really enabled us to provide extended year services to our students and to compensate our staff very well for their time/efforts.

We have only a few weeks until school and we have been able to hire almost all our open positions. We have filled 4 special education teaching positions, health instructor, HS and Elementary secretaries, 2 elementary teaching positions, 2 MS teaching positions, two paras, a bus driver and a dean of students. We are still looking for a math teacher and a driver's education teacher...but have contingencies if needed.

Our Motor for the cooling tower had a bearing go out on it last week. Richards gave us a quote on the cost to repair and refurbish the motor (\$3200) but the cost was better to buy a new one at \$4200.00.

Our doors from Doors-N-More for the MS cafeteria and the west ag hallway entrance are scheduled to arrive the first week of August and should hopefully be installed prior to school beginning unless they have a delay in delivery.

The elementary playground project is moving forward. We have the groundwork scheduled to be done the last week of July or first week of August depending on weather. We are taking out the dirt and placing it for reuse by the little league ballfield. We will then put in the rock and the border once it arrives. Then we will work with the community organizations on putting in the equipment. Bob Venvertloh will be present at the install to help with placement and correct depth, etc.

The leak behind the football field was determined to be the sprinkler system. We are contacting the company that installed it to repair the leak.

The last of the one-touch security locks are being installed this week in the elementary school.

The maintenance/custodial crew has been finishing up waxing on both campuses, painting and retouching hallways and classrooms as needed, cleaning furniture and carpets, repainting parking lot lines, installing ceiling tiles in the ag classrooms, and changing out filters in the HVAC units.

We have been working with Klingner's on putting out a bid for the front window phase replacement. We are also in discussion about security film for our front entryway. They did a project before where they used hurricane film (which stops a 2x4 going 200 mph) to cover entryway windows. The bid process has slowed down the project, but it will provide us with the options.
