# Community Unit School District #4 Board of Education Report

#### Visitors Present - 10

#### **Financial Items**

- Approved bills and activity fund reports.
- Held Public Hearing on Tax Levy. District EAV is expected to increase approximately 6%, but the bond levy will remain level. This would create an aggregate proposed levy of \$2,387,879. This is a 9% increase over the 2013 aggregate levy. However, the tax rate is estimated to remain the same at 4.59%.
- Heard review of fund status. Concerns were expressed that CUSD #4 may not receive final two state aide payments for FY15. This would cost the district about \$210,000 in revenue.

# Informational Items

- Heard Mark Pfleiger, Director of QAVTC, share about the programs and opportunities for students offered through the vocational center.
- Heard Tom Arnold of ABNG share an overview of the district's audit. Tom pointed out the trend from
  the past four years. Tom commended the district on their financial management. He noted that the
  district continues to hold the line on spending, but a larger percentage of revenues are coming from
  local dollars. He also noted that the amount of revenue that comes from the State of Illinois has
  continued to decrease over the past 4 years.
- Reviewed timeline for School Board elections. Filings must be made with the Adams County Clerk by and 12/22/2014.
