### **Financial Items**

- Approved bills and activity fund reports.
- Approved interfund loan of \$40,000 from Building Fund to Education Fund.
- Discussed the State of Illinois Education Budget approved by Governor Rauner earlier during the day. The Board also discussed the negative impact continued proration of General State Aid will have on the district.

## **Action Items**

- Approved individual student-athletes at Unity High School to participate in cross-country as a self-funded, individual
  opportunity.
- Approved Prairie State Insurance Cooperative (PSIC) for the insurance coverage package Broker's Risk for the treasurer's bond for a premium savings of \$26,396 or 20.59% less than the expiring policy.
- Approved school handbooks for Unity Elementary, Unity Middle School, and Unity High School.
- Approved school fees for 2015-16 school year. Technology fees and admissions prices will remain steady. Breakfast
  and lunch prices will increase slightly. A public hearing was set for 6:00 p.m. on Wednesday, July 15<sup>th</sup> in the CUSD 4
  Board of Education Office on raising the Driver Education Fee from \$200 to \$250.
- Approved Board of Education Regular Meeting Schedule. The next meeting will be in the CUSD 4 Board of Education
  Office at 6:00 p.m. on Wednesday, July 15<sup>th</sup>. After summer work is completed, meetings will return to the Unity High
  School Library in August.
